1. Permits, Change, Transfer, Renewal, Sale

The current DOGM permit C/007/020 was issued effective 10/11/2011 and expires 10/11/2016.

-Certificate of Insurance certificate #4413805 issued 06/04/2012 and terminates 06/04/2013.

-UPDES permit UTG040000 (General) UTG040019 (Site Specific) effective 05/01/2008 and expires midnight 04/30/2013.

-Air Quality permit DAQE-700-70, issued November 7, 2000.

-SPCC Plan dated January 2010. The Plan is P.E. certified, stamped, signed and dated by a Utah P.E.

2. Signs and Markers

The mine identification sign is found along side of the Carbon County road used to access the Mine Site and prior to entrance into the Mine Permit area. The sign contains the required information set forth in the Utah R645 Coal Rules. The sign is in compliance with the regulations.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

First quarter 2013 sediment pond inspection was done on February 15, 2013. No problems were noted in this sediment pond inspection.

4.e Hydrologic Balance: Effluent Limitations

Reviewed the January 2013 discharge monitoring reports. No parameters were identified as exceeding their limits. The reports were submitted to the Department of Water Quality for the State of Utah.

8. Noncoal Waste

Items of noncoal waste were observed in the main diversion to the side of the bath house. Personnel picked up the items during the inspection.

20. Air Quality Permit

The Air Quality Permit Approval Order DAQE-700-00 was issued on November 7, 2000. Recent documentation shows the approval order number as DAQP-002-06.

21. Bonding and Insurance

The bond is secured by a letter of credit through Bank One in the amount of \$57,000 and collateral to add up to the amount of \$342,000. This letter of credit expired on January 20, 2007. The appraisal was updated as of 12/20/06 for the real estate (collateral) and the appraisal is now \$625,000 and the collateral is adequate. The updated reclamation cost estimate is \$445,000 in 2011 dollars.
