2. Signs and Markers

The mine identification sign is located at the entrance into the permit area along the right side of the county road looking up-canyon. The sign contains the name, address, telephone number and mining permit number. The sign is compliant with the Utah R645 Coal Rules.

3. Topsoil

Topsoil piles have protection around their perimeter and are signed.

4.a Hydrologic Balance: Diversions

The main diversion has been cleaned since the previous inspection. The diversion is functional.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The ice cap on the surface of the sediment pond has melted. Pond contains water. No discharge.

5. Explosives

Powder and cap magazines are grounded and signed as required.
