

**4.a Hydrologic Balance: Diversions**

By removing the coal located on the lower pad, the elevation of the pad has been lowered, making the ditches no longer necessary. The water collected on the lower pad remains within the disturbed area and is eventually routed to the pond. It was emphasized with during the insepction, that during work, any off site flow must be prevented.

**4.b Hydrologic Balance: Sediment Ponds and Impoundments**

The pond is still in need of repairs and cleaning to return it the approved design contained in the MRP.
