Report summary and status for pending enforcement actions, permit conditions, Division Orders, and amendments:

During the inspection work was being done on site to remove the rest of the coal from the lower pad. A truck arrived to remove the coal to the Wellington Dry-Coal Cleaning facility. The pile of coal has been reduced significantly and should be gone by the third week of February.

The lower pad was muddy, but as coal removal was taking place, the workers were keeping the drainage from the pad flowing into the pond. The upper section of the site was still snow covered but was still mostly accessible, except for the uppermost section of the disturbed area.

The sediment pond was still frozen and snow covered, although the banks, inlets and outlet were not. The banks and inlets still have fairly significant erosion, although the erosion doesn't look as though it has progressed much recently due to winter conditions at the site.
