

1. Permits, Change, Transfer, Renewal, Sale

The DOGM permit expires Oct. 11, 2016.

2. Signs and Markers

The sign is displayed as required at the entrance to the facility.

4.a Hydrologic Balance: Diversions

Ditches are functioning properly throughout the site. Following the removal of coal fines from the lower pads, ditches were re-established to convey drainage to the pond.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The sediment pond is still in need of maintenance. Water was observed in the pond.

4.d Hydrologic Balance: Water Monitoring

During conversations with Kit Pappas, he mentioned that 1st quarter 2015 water monitoring was attempted in March, but only two sites were accessible. Pictures were observed of the impassable road conditions to the upper water monitoring sites.

4.e Hydrologic Balance: Effluent Limitations

The UPDES permit for the site expires August 31, 2018.

8. Noncoal Waste

A small pile of noncoal waste is stored on the lower pond. This was waste that was removed from the coal fines as they were trucked from the site. This waste should be disposed of properly.

19. AVS Check

The AVS system was checked on March 30, 2015.

20. Air Quality Permit

The air quality permit was revoked on 11/13/2013 due to the facility no longer being in operation.

21. Bonding and Insurance

The facility is bonded for \$445K, The liability insurance is effective through 12/3/2015
