2. Signs and Markers

The facility sign still clearly displays the required information.

4.a Hydrologic Balance: Diversions

The inlet to culvert DC-2 has had an elbow placed on it. The permittee has indicated that this was put in place to help prevent future clogging of the culvert. Water was ponded in the basin at the inlet of the culvert.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The sediment pond looked similar to its condition during the previous months inspection. It does not appear that any maintenance work has taken place on the pond.

4.e Hydrologic Balance: Effluent Limitations

The two outfalls associated with the site's UPDES permit have not reported had any discharge.
