

4.a Hydrologic Balance: Diversions

All ditches and culverts were inspected. Each ditch and culvert needed maintainance. The upper undisturbed diversion culvert was open and free of debris. The lower disturbed drainage culvert DC-2 was even more buried than during the last inspection. NOV 21182 is still outstanding.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The sediment pond is still mostly full of water. At this point any rainstorm may cause the sediment pond to discharge.

4.c Hydrologic Balance: Other Sediment Control Measures

The site is continuing to erode.

4.d Hydrologic Balance: Water Monitoring

Water monitoring is not taking place.

4.e Hydrologic Balance: Effluent Limitations

DMRs are not being submitted to DWQ.
