## **9. Protection of Fish, Wildlife and Related Environmental Issues**

Noxious weeds being controlled are black henbane, hounds tongue, musk thistle, Canadian thistle, bull thistle. Black henbane and hounds tongue was on the slopes prior to reclamation. Much of the thistle source was liely the topsoil pile.

Carbon County weed crew (Chris, Tom, and Alissa) sprayed a combination of Weed Master, Telar and Tordon to control the above weeds. Their focus was the black henbane and thistle. Hounds tongue is is found over the entire site, more so than the thistle which appeared concentrated in 2 acres above the former portals.

Justin and Priscilla spent the remainder of the day pulling seed heads from the treated thistle and henbane, to prevent the sprayed plants from producing seed.
