The Utah Division of Oil, Gas and Mining (Division) has granted approval and issued a reclamation permit to North American Equities. The Division has determined that the permit application is technically complete and demonstrates compliance with all the "Regulations Pertaining to Surface Effects of Underground Coal Mining Activities, Final Rules of the Utah Board and Division of Oil, Gas and Mining," promulgated under the Utah Coal Mining Reclamation Act (UCA 1953, Section 40-10-1 et seq.).

Notice is hereby given to all appropriate agencies and individuals having jurisdiction over, or an interest in the reclamation of the minesite, pursuant to UMC 786.23(d)(3)(f), that a permit has been issued to said permittee.

This permit authorized the permittee, North American Equities, NV to conduct reclamation operations on the described lands within the permit area at the Blazon #1 Mine situated in the State of Utah, County of Carbon, subject to the approved Final Closure and Reclamation Plan, the permit and all applicable laws and regulations.
