NOTICE OF DECISION

To Whom It May Concern:

Pursuant to the Utah Coal Mining and Reclamation Act (Utah Code Annotated 1953, Section 40-10-1 et seq.), and the "Regulations Pertaining to Surface Effects of Underground Coal Mining Activities" (Final Rules of the Utah Board of Oil, Gas and Mining), the Utah Division of Oil, Gas and Mining has issued a permit to reclaim to North American Equities for its application No. INA/007/021. The Company will reclaim in accordance with the approved Final Closure and Reclamation Plan for the Blazon #1 Mine associated with fee coal, and the following lands:
