INA/007/021, Folder #8, Carbon County, Utah

Enclosed is the proposed civil penalty reassessment for the above referenced violation. This violation was issued by Division Inspector Tom Wright on March 25, 1985. Rule UMC/SMC 845.2 et seq. has been utilized to formulate this reassessment. In Addition, a June 25, 1985 attorney general's review of 40-10-22 (i)(e) U.C.A. has pointed out a 30 day statutory limitation on Cessation Orders. Thus this CO has been reassessed.

Within fifteen (15) days after receipt of this reassessment, you or your agent may file a written request for an assessment conference to review the proposed penalty. (Address a request for a conference to Ms. Jan Brown, at the above address.) If no timely request is made, all pertinent data will be reviewed and the penalty will be reassessed, if necessary, for a finalized assessment. Facts will be considered for the final assessment which were not available on the date of the proposed assessment, due to the length of the abatement period. This assessment does not constitute a request for payment.


