This is to confirm our previous verbal committment to plant red-osier dogwood, willow and choke cherry within 20 feet of the mud creek channel center line during the first favorable planting season, (no later than June 15, 1988).

Further, formal application will be made to transfer the well and water rights to Jack Otani. The documented approval will be sent to you as soon as we receive it from the agency.

Please accept this letter as a request for administrative relief as previously discussed with Rick Summers for the N.O.V. just issued and the F.T.A. that was mailed from your office Wednesday the 15th of July. It seems it is time, once again, to sit down and discuss with DOGM the Blazon Mine reclamation. I have just been informed by Jack Otani that he has now been told that he can not start dirt work until he gets your approval. This is getting to be absurd. Please advise if you can meet along with Ken May, Jack Otani and myself August 4, 1987.
