Violation No. 1 of 1

Nature of violation

FAILURE TO MITIGATE HIGHWALL DURING RECLAMATION IN ACCORDANCE WITH THE REGULATIONS.

Provisions of act, regulations or permit violated

UTAH COAL MINING RULES - R614-301-553.

Portion of operation to which notice applies

HIGHWALL AREA ALONG THE PORTAL BENCH AND THE PORTAL ACCESS ROAD.

Remedial action required (including any interim steps)

1. SUBMIT PLANS FOR REMEDIAL ACTION ON HIGHWALL RECLAMATION FOR APPROVAL BY THE DIVISION.
2. COMPLETE REMEDIAL RECLAMATION WORK ON HIGHWALLS INCLUDING ALL INCIDENTAL RECLAMATION/REVEGETATION WORK NECESSARY.
