1. PERMITS, CHANGE, TRANSFER, RENEWAL, SALE

Current status and information regarding the Blazon Mine site is essentially the same as the last complete inspection. Refer to that complete inspection dated 9/25/92 for detailed information regarding the status of the site.

UP&L has done some repair work to the powerline entering the site to eliminate the danger of lines under high tension, but downed poles on the site remain.

On December 9, 1992, a meeting was held regarding final reclamation of the Blazon mine with Steve Tanner, Dianne Nielson and Lowell Braxton. The meeting was held to informally discuss landowner's issues regarding liability, improper board action and general complaints. A memo discussing these issues was written to file by Lowell Braxton, dated December 15, 1992.


The site is currently under winter stasis conditions. The stream is now completely frozen and no water is flowing through the site. Snow cover over the entire site ranges from 6-24 inches. Snowmelt or runoff conditions are not expected to occur on the site till spring.
