North American Equities, NAE, has declared insolvency and is unresponsive to all notices and orders submitted by the Division. Bond in the amount of \$38,000 was forfeited on May 31, 1991. The Division is currently evaluating reclamation treatments in lieu of the bond amount forfeited. The Division has requested that OSM Operations and Technical Services assist in design criteria for final reclamation work.

4b. Diversions -

The diversion contains rocks and sediment and needs to be redefined.

4c. Sediment Ponds and Impoundments -

Pond was not discharging at the time of inspection. No problems were noticed.
