General Comments. The inspection started with a meeting. Two agenda items were discussed i.e., (1) Mr. Sauls, Savage Industries Inc, responded in writing to the inspection report dated 7/10/95. (2) Discussed transitional matters. Thereafter a field partial inspection was completed.

Signs & Markers. New ID and refuse pile signs had just been received. The operator stated he would install the signs promptly. The disturbed markers are in place and does not carry the permittee logo. Therefore, the disturbed markers do not need to be changed.

Sediment Ponds. Pond 5 has been cleaned and the material stockpiled adjacent to the pond. The material was sampled and Elkh Coal Co. is making arrangements to store the material at an approved site that has been cleared for the storage of contaminated material.

Roads. Roads were graded to the north coal grizzly. Haul roads were watered to control fugitive dust. This was done before and during the inspection.
