Wildlife have been grazing in the reclaimed area.

10. Slides and Other Damage

No slides or other damage was noticed during the inspection.

12. Backfilling And Grading

The mine site was completely backfilled and graded.

13. Revegetation

The site is highly vegetated and diverse with different plant life.
