The Utah Division of Oil, Gas and Mining (Division) has granted approval and issued a five year mining permit to Beaver Creek Coal Company. The Division has determined that the permit application is technically complete and demonstrates compliance with all the "Regulations Pertaining to Surface Effects of Underground Coal Mining Activities, Final Rules of the Utah Board and Division of Oil, Gas and Mining," promulgated under the Utah Coal Mining Reclamation Act (UCA 1953, Section 40-10-1 et seq.).

Notice is hereby given to all appropriate agencies and individuals having jurisdiction over, or an interest in the permit of the proposed operations, pursuant to UMC 786.23(d)(3) (f), that a permit has been issued to said permittee.

This permit authorizes the permittee, Beaver Creek Coal Company, to conduct coal processing and reclamation operations on the described lands within the permit area at the C. V. Spur Preparation Plant situated in the State of Utah, County of Carbon, subject to the terms and the lease(s), the approved mining and reclamation plan, this permit and all applicable laws and regulations. 
