**1. Permits, Change, Transfer, Renewal, Sale**

The permittee has no permitting actions with the Division.

**2. Signs and Markers**

The permittee has ordered two new identifications signs for the main gates to the Savage Loadout. The signs are to update the change in phone area code from 801 to 435.

**3. Topsoil**

Snow has melted off the topsoil stock pile. There were no signs of wind or water erosion.

**4.a Hydrologic Balance: Diversions**

Several of the diversions have been cleaned and re-graded since the last inspection. The permittee plans to continue re-grading diversions as ground conditions dry out.

**4.b Hydrologic Balance: Sediment Ponds and Impoundments**

Most of the sediment ponds did contain water but were not discharging. No hazardous conditions were noticed during the inspection.
