1. Permits, Change, Transfer, Renewal, Sale

The Permittee is making modifications to the wash plant building (internally) in preparation for the start up of those coal washing facilities. An amendment to construct four minus 28 mesh clean coal settling basins has recently been submitted and is under review within the DOGM. These basins are intended to replace the clean coal thickener which was reclaimed after the wash plant was shut down in 1984.

18. Support Facilities, Utility Installations

The concrete foundation for the newly permitted raw coal stacking tube (Task ID #2463) is being constructed; the contractor anticipated that the pour would occur during the week of June 5, 2006.

20. Air Quality Permit

A water truck was observed operating on the site's primary roads during today's inspection.
