2. Signs and Markers

Mine ID signs were present at the points of public access to the permit area. The signs contained the required information. No ID sign for the refuse pile could be found. Dan Guy (Blackhawk Engineering) representative for the company during the inspection indicated that the sign would be located and posted or that a new sign would be obtained and posted.

7. Coal Mine Waste, Refuse Piles, Impoundments

The surface of the refuse pile remains uneven with excavated un-compacted piles and holes from test pits. The concerns referenced by the Division in the prior inspection had not been addressed as of this inspection.
