3. Topsoil

The topsoil and subsoil piles associated with the four fine coal settling ponds are showing more sprouting.

4.a Hydrologic Balance: Diversions

The 18 inch corrugated metal pipe just north of the truck scale has been run over, crushing about 2/3 of the inlets cross sectional-area. The delineator post adjacent to the culvert has also been pushed over. Mr. Guy took action during the inspection to have repairs made to the under road culvert.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

Ponds #1, 2 and 3 were very low or dry, and were capable of containing and treating the intercepted runoff from the 10 year, 24 hour event. A slight trickle of water was reporting into pond #1 from the coal preparation plant.

4.d Hydrologic Balance: Water Monitoring

UPDES outfall #001 (CV-15-W) was not flowing this day, although pond #6 was near capacity. Ditch UD-1, which parallels the north permit boundary was dry.

4.e Hydrologic Balance: Effluent Limitations

The Permittee received a UPDES renewal from the Utah Division of Water Quality on April 23, 2008.

20. Air Quality Permit

The Permittee was applying water to the sites primary haul roads during today's inspection.
