Sediment ponds and impoundments were inspected. I did not notice any hazardous conditions. Some ponds did contain water.

7. Coal Mine Waste, Refuse Piles, Impoundments

The refuse pile was inspected and I did not see any hazardous condition. The pile appear to be stable.

8. Noncoal Waste

The site was clear of non-coal waste material.

Road drainage was working as the permittee was water the dirt roads for dust control.
