4.a Hydrologic Balance: Diversions

The belt material which has been installed to minimize erosion on the ENE corner of the waste rock pile needs to be pulled back up such that the outlet of the stub CMP discharges onto the belting. Erosion beneath the belt material may occur if this is not done; all runoff reports from the refuse pile into pond #5. The east end of diversion CV-1-W needs dressing up to allow the ditch to function properly.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

Ponds 5 and 6 were both inspected this day. Pond 6 is at capacity, but it was not discharging. Pond 5 contained water, which was well below the discharge elevation.

4.c Hydrologic Balance: Other Sediment Control Measures

The Permittee needs to install new straw bales at the inlet of culvert C-15 (24 inch CMP) located in the NE corner of the disturbed area. The Permittee cleared the ditch of weeds by burning them off; the existing bales were damaged in that process.

7. Coal Mine Waste, Refuse Piles, Impoundments

The NE side of the refuse pile needs to be re-graded.

8. Noncoal Waste

The Permittee asked to resume clean up efforts in the equipment storage area east of the prep plant area.

20. Air Quality Permit

The operational roads at the site were being watered during today's inspection.
