3. Topsoil

The Permittee has received a conditional approval from the Division (Task ID # 3421) for the addition of six new species to the temporary seed mix approved for the topsoil and subsoil piles constructed from the fine coal settling basins. Table 5-1, Page 57 of the mining and reclamation plan has been amended to include these species for high clay / high SAR content soils. As observed this day, all piles are snow covered. Field work will be initiated in the spring.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

All ponds are snow covered or frozen. Mr. Guy re-certified settling ponds #3 and #4 on December 10, 2009.

7. Coal Mine Waste, Refuse Piles, Impoundments

The Permittee continues to load and ship material from the coal processing waste pile to Sunnyside Co-generation Associates in Sunnyside, Utah. The material is being blended for power generation feed.

20. Air Quality Permit

Ambient air temperatures are too low to allow for roadway dust suppression; opacity limits appear to be in compliance with the DAQ air quality approval order.
