4.a Hydrologic Balance: Diversions

Diversions which were not snow covered appeared capable of functioning as designed.

7. Coal Mine Waste, Refuse Piles, Impoundments

Approximately half the volume of the refuse pile has now been removed and shipped to Sunnyside Co-Gen. The Permittee has ripped the remaining volume with a track hoe, and stockpiled this material in smaller conical volumes to make loading via a front end loader easier. According to Mr. Fausett, ripping of the pile with a dozer was very hard on the Permittee's machinery. Digging with the track hoe makes bucket loading more efficient and compatible for the front end loader / truck combinations.

16.a Roads: Construction, Maintenance, Surfacing

The operational pads of the site are very muddy due to snow melt water sheet flowing across them. The ditch reporting runoff from the refuse pile area to Pond #5 was functioning.
