2. Signs and Markers

The identification signs was inspected and complied with the R645 Coal Rules.

3. Topsoil

The permittee has top soil stock piles. There were no signs of wind or water erosion.

4.a Hydrologic Balance: Diversions

A couple of diversions will need to be re-graded after sediment are cleaned out. Trucks are crossing the diversions to clean out ponds.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

Several of the sediment ponds used by the preparation plant are in the process of being cleaned out. No hazardous conditions were noticed during the inspection.

4.d Hydrologic Balance: Water Monitoring

The permittee later in the week will be drilling a new water monitoring well near the coal loadout/ railroad tracks.

7. Coal Mine Waste, Refuse Piles, Impoundments

The refuse pile was inspected and I did not see any hazardous conditions.

8. Noncoal Waste

The site was clear of non-coal waste materials.

16.a Roads: Construction, Maintenance, Surfacing

Roads were in good condition and wetted down for dust control.

16.b Roads: Drainage Controls

The diversions were functioning as designed.
