2. Signs and Markers

Identification sign was at gate to permit area. The information meets the minimum requirements of the R645 Coal Rules.

3. Topsoil

The topsoil pile was stable. There were no signs of wind or water erosion.

4.a Hydrologic Balance: Diversions

Several diversions throughout the property will need maintenance in the near future. The past few days the loadout has been rainstorms. The culverts and diversions are functioning but may not if rainstorms continue.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The sediment ponds contain small amounts of water from the recent rainstorms. No hazardous conditions were noticed. It is unlikely that the sediment ponds will discharge in the near future.

7. Coal Mine Waste, Refuse Piles, Impoundments

There is a small refuse pile. This material came from scraping and leveling the pad area. There are no hazardous conditions. All material will be ship to Sunnyside Co-Gen.

8. Noncoal Waste

The site was clear of non-coal waste materials.

16.a Roads: Construction, Maintenance, Surfacing

Roads were wet and nearly dust free.

18. Support Facilities, Utility Installations

No new facilities were constructed since the last inspection.
