2. Signs and Markers

The mine identification sign was found at the entrance into the mining permit area from a public access point. The sign contained the required information.

3. Topsoil

The diversion on the South side of the topsoil pile has been re-graded since the previous inspection. The diversion appears to be functional and to meet design.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The annual sediment pond inspections have been revised and re-submitted to show the 60% elevation of each sediment pond so that a comparison can be made against the existing sediment level.

All sediment ponds showed a minimal amount of water in them. Ponds appeared stable. No visible hazards were observed during the partial inspection.

16.a Roads: Construction, Maintenance, Surfacing

Roadways throughout the site have been graded and are well maintained.
