The mine identification signs at both entrances from a public access were inspected. Both of the mine identification signs meet the requirements set forth in the Utah Coal Rules relative to identification signs.

3. Topsoil

The southern berm has been recently maintained since the previous inspection. The cut in front of the berm had filled with sediment. The re-establishment of the berm now allows for retention of soil from the topsoil pile

The diversions throughout the site were checked and found to be functional. A recent storm event yesterday demonstrated that the diversions are functional.
