2. Signs and Markers

Two entrances from the public are open for access into the mining permit area. Identification signs are posted at both access points. These signs contain the address, phone number, mining permit number and name of the company. The signs are in compliance with the coal rules.

4.a Hydrologic Balance: Diversions

The diversions through out the site are open and functional.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

One of the four ponds used in conjunction with the preparation plant underflow has been cleaned out. The material is currently drying and then will be removed or blended back into the coal stream.

8. Noncoal Waste

The terminal site was free of noncoal waste items outside of an approved containment.
