2. Signs and Markers

The Savage Energy terminal has to site identification signs posted. A sign is in place at the east and west entrance into the facility from Ridge Road. The signs contain the name of the company, address, phone number and mining permit number. These signs are posted at the entrance into the permit area. The signs were inspected and found to be compliant.

4.a Hydrologic Balance: Diversions

The diversions are frozen and snow covered from a storm event that occurred yesterday.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

Water that was in the ponds has been pumped down prior to the storm event that occurred yesterday. A little bit of water remaining in the ponds is frozen over.
