2. Signs and Markers

Identification signs are posted at two entrances into the permit area from public access points. Both signs were examined during the partial inspection and were found to be in compliance with the regulations.

4.a Hydrologic Balance: Diversions

Examined several diversions. Diversions were functional. All diversions in the permit area blanketed by snow.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

Examined sediment ponds as part of the partial inspection. Ponds containing water are iced over. All ponds are blanketed by snow from recent storms. Ponds appear to be functional. No structural weakness identified.
