2. Signs and Markers

There are two identification signs posted at points of access from the public into the permit area. Both of these signs were checked as part of the inspection. The signs have been fixed to show the proper permit number. All other information is present and correct. The signs are compliant with the coal rules.

Diversions throughout the site are well maintained. Inlets and outlets to culvert pipes were found open and functional upon inspection.
