2. Signs and Markers

Both identification signs were checked at different access points into the permit area. These signs are clearly displayed and contained all of the required information. Both signs are in compliance.

4.a Hydrologic Balance: Diversions

All of the diversions throughout the site are well maintained. They have been recently graded. The diversion structures, culvert inlets and outlets, were open and functional.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

Several ponds contained water during the inspection. A few of these ponds are ponds associated with the preparation plant. No problems were observed. The structures appeared stable.

5. Explosives

No explosives or explosive storage area are on site.

8. Noncoal Waste

The site was free of noncoal waste items outside of the approved containment facilities.

14. Subsidence Control

Not applicable for this site.

16.a Roads: Construction, Maintenance, Surfacing

The roadways are well maintained. They have been recently graded and watered for dust suppression.
