

2. Signs and Markers

Checked both identifications signs associated with the Savage Energy Terminal. The signs are locate at different access points. Both of these signs are identical in construction. They include the name, address, phone number and permit number of the operator as required by regulation.

4.a Hydrologic Balance: Diversions

The diversions throughout the entire site were examined and found to be open and functional. The diversions are well maintained.

5. Explosives

No explosives are maintained or stored on site.

8. Noncoal Waste

The site was void of any noncoal waste items outside of an approved storage vessel.

22. Other

The erosion rill coming off the slope from the truck dump evaluated pad has been repaired. This erosion rill was identified on a previous inspection.
