## **2. Signs and Markers**

The identification signs at the Savage Energy Terminal contained the name, address, phone number and permit number for the site. These listed items fulfill the requirements of the Utah Coal rules for identification signs. The signs are compliant.

### **4.a Hydrologic Balance: Diversions**

The diversions at the site were open and functional. The site had received rain fall earlier in the morning and the diversions all showed signs that they were adequate to handle the runoff.

### **4.b Hydrologic Balance: Sediment Ponds and Impoundments**

Sediment ponds at the site contained some water from the rain fall prior to the inspection. The ponds appeared stable.

## **5. Explosives**

No explosives are stored or maintained on site.

## **7. Coal Mine Waste, Refuse Piles, Impoundments**

The refuse pile has an identification sign to show its location. The pile appeared stable. No visible hazards were observed.
