2. Signs and Markers

There are two entrance identification signs at the Savage Energy Terminal. Both of these signs are identical to each other and contain the name, address, phone number and Utah Mining permit number as required by law. The signs were checked and found to be in compliance with the law.

3. Topsoil

The topsoil pile has sparse vegetation on it, Other protection includes an earthen berm and a silt fence on the West side that is used as a wind fence to help keep coal fines from depositing on the topsoil pile.

4.a Hydrologic Balance: Diversions

Diversions on site were open and functional.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The main sediment pond used to collect run off and capable of discharge offsite is slated to be cleaned in the near future.

5. Explosives

No explosives are stored or maintained on site.

7. Coal Mine Waste, Refuse Piles, Impoundments

Refuse pile foot print is small. The pile is compacted and stable.
