## **2. Signs and Markers**

Two identification signs are placed at the permit entrances from separate entrances leading into the Savage Energy Terminal permit area. The law requires that these signs display the name, address, phone number and permit number. Both of these signs contained the required information. The signs are in compliance with the law.

### **4.a Hydrologic Balance: Diversions**

The road diversion near the topsoil pile needs to be re-established.

## **7. Coal Mine Waste, Refuse Piles, Impoundments**

It appears that material has been placed on the refuse pile that needs to be leveled and compacted.

### **16.a Roads: Construction, Maintenance, Surfacing**

Roadways are well graded and maintained.

## **18. Support Facilities, Utility Installations**

An amendment for a shop and storage containers addition has been prepared, but not submitted. The shop and storage containers are already constructed and in place. Pictures of the area were taken and are attached to the PDF version of this inspection report. Notice of Violation (NOV) #21225 was issued on 03/09/2020 for not submitting and receiving an amendment approval prior to construction.
