3. TOPSOIL -

The topsoil piles were inspected with no signs or erosion occurring. The soil is contained by berm.

4A. DIVERSIONS -

The diversions throughout the property were spot-checked. Several of the diversions were recently cleaned out. The ditches were dry during the inspection with no breaching noticed. The diversions would most likely function as designed.

4B. SEDIMENT PONDS -

The sediment ponds contained little or no water. The pond showed no sign of major erosion or hazardous conditions existing.
