Much of the site remains under frozen snow, which was received over the Christmas holiday in the Carbon County area. Many of the diversions are under snow. All of the sediment ponds have snow covered inslopes, or contain frozen snowmelt in their bottoms. Some roads have not been plowed. There were no snow removal blockages noted in any of the site's diversions. Much of the Wildcat coal stockpile volume has been shipped from the site.
