**4.b Hydrologic Balance: Sediment Ponds and Impoundments**

Ponds A, B, C, D, and E were observed as dry. There were no compliance issues noted.

**4.d Hydrologic Balance: Water Monitoring**

There was no flow observed in Wildcat Wash during today's inspection.

**4.e Hydrologic Balance: Effluent Limitations**

The Permittee received a UPDES permit renewal for the six permitted outfalls at this site on April 23, 2008. Pond "E" is the only pond which has ever discharged (summer, 2007).

**7. Coal Mine Waste, Refuse Piles, Impoundments**

The current lift of the waste rock disposal area is very near or at capacity. Mr. Dimick intends to rework the pile, expand it to the east for additional storage capacity. The maximum thickness of this pile is twenty feet, with 2:1 outslopes. This pile is inspected quarterly by the Permittee and certified by a professional engineer. The MSHA identification number is in place adjacent to the north access. Both MSHA and the Division monitor the storage facility.

**20. Air Quality Permit**

Evidence of a recent water application on the haulroads was visible. The roads appear well graded and compacted. Trucks are adhering to the posted 5 MPH speed limit. Opacity levels observed to the rear of trucks leaving the site appeared to be within the levels established within the air quality approval order.

**21. Bonding and Insurance**

The general liability insurance for all of the UtahAmerican sites was renewed for one year, effective June 1, 2008.
