2. Signs and Markers

Identification signs is by the main gate. Information meets the minimum requirements of the R645 Coal Rules.

3. Topsoil

The topsoil piles were inspected and are stable. There were no signs of wind or water erosion.

4.a Hydrologic Balance: Diversions

The diversion were spot-checked and would function during a storm event. Several were recently cleaned out.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The sediment ponds were dry and no hazardous condition noticed during the inspection.

7. Coal Mine Waste, Refuse Piles, Impoundments

The refuse pile was inspected with no hazardous condition noticed during the inspection.

8. Noncoal Waste

The site was clear of non-coal waste materials. It's the cleanest site I have been on for several years.
