4.a Hydrologic Balance: Diversions

The Permittee has initiated spring maintenance of the ditches along primary haul road PR-6. All culvert inlets appeared capable of functioning as designed.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

All of the snow covering Ponds A-E had melted, with the exception of pond "F", which remains half covered. None of the ponds are close to discharge.

4.d Hydrologic Balance: Water Monitoring

The Permittee's water monitoring contractor notified the Division on February 2, 2010 that the 4th quarter 2009 surface water monitoring data for the Wildcat loadout permit area was in the DOGM data base pipeline, ready for uploading. Division hydrologist J. D. Smith reviewed this data on March 2, 2010, indicating that all UPDES and DOGM permit conditions had been met by the Permittee.

7. Coal Mine Waste, Refuse Piles, Impoundments

The operational surface of the waste rock pile remains snow covered; all outcrops have melted off. All appear stable.
