3. Topsoil

Topsoil piles were clearly marked and no unexpected erosion was taking place.

4.a Hydrologic Balance: Diversions

The diversions and ditches throughout the site were clear of debris. Scott Dimick indicated that they had recently cleared all the ditches of blown in weeds.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

Pond B has not yet been cleaned out, the pond has not reached its cleanout marker yet.

4.d Hydrologic Balance: Water Monitoring

All required water monitoring has been submitted to the division database as required in the DOGM permit.

4.e Hydrologic Balance: Effluent Limitations

All of the 6 sediment control ponds have UPDES outfalls, but the ponds have not discharged in years.

10 deer were grazing on the west side of the permitted area.
