**2. Signs and Markers**

Topsoil piles and sediment control pond are all clearly marked. The company and permit information is displayed at the main entrance to the loadout.

**3. Topsoil**

The berms surrounding the topsoil piles all appeared to be in good repair.

**4.a Hydrologic Balance: Diversions**

Ditches throughout the facility were clear of debris.

**4.b Hydrologic Balance: Sediment Ponds and Impoundments**

Pond B should be cleaned out soon. There is about 6 inches of freeboard left before hitting the clean out mark.

**16.b Roads: Drainage Controls**

The ditches along the side of the facility roads were clear of debris.
