**1. Permits, Change, Transfer, Renewal, Sale**

Dan Baker indicated that the BLM is still working on updating their lease to include the operation changes necessary now that they are trans-loading oil.

The depression area on the west side of the facility had accumulated water. Ponds C and D both had water in them.

Water monitoring data has been submitted to the DOGM database as required in the permit.

Discussed the status of UPDES permit updates with Dan Baker. A call has been placed with Mike Herkimer with DEQ to confirm that the facility is moving forward with necessary updates.
