1. Permits, Change, Transfer, Renewal, Sale

The permittee recently received approval for Task ID 4593. Their DOGM permit was recently renewed and expires on May 5, 2019.

2. Signs and Markers

Signs are clearly displayed to indicate appropriate company information.

3. Topsoil

Topsoil piles are marked and appear to be in stable condition.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

Pond inspections were recently conducted by Tom Poluso, and inspection forms for March 24, 2014 were reviewed. All six sediment ponds have adequate sediment storage volume, and contain cleanout markers.

4.d Hydrologic Balance: Water Monitoring

Water monitoring data has been submitted to the DOGM database as required in the permit.

4.e Hydrologic Balance: Effluent Limitations

Current DMRs have been submitted to DEQ, and copies have been received by the Division.

7. Coal Mine Waste, Refuse Piles, Impoundments

The refuse pile inspections were reviewed, and the pile appears stable.

8. Noncoal Waste

The facility is free of noncoal waste.

20. Air Quality Permit

The facility's air quality permit was approved on December 3, 2011.

21. Bonding and Insurance

The facility is bonded for an amount of \$1,144,000 and is self-insured
