3. Topsoil

The topsoil piles were inspected with no signs of wind or water erosion. There is not abundances of vegetation growing on the piles.

4.a Hydrologic Balance: Diversions

The diversions and culverts were open and would function during a storm event. No water was flowing within the diversions during the inspection.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The sediment ponds were inspected with no hazardous conditions noticed during the inspection. The sediment ponds were dry and not likely to discharge water during the summer.

7. Coal Mine Waste, Refuse Piles, Impoundments

I inspected the refuse pile. There were no signs of a hazardous condition. The embankments were stable. Water was diverted away from the refuse pile by a berm and diversion.

8. Noncoal Waste

The site was clear of non-coal waste materials.

16.b Roads: Drainage Controls

Road drainage was functioning as design. The diversions and culverts were open.
