1. Permits, Change, Transfer, Renewal, Sale

There is no pending amendment action with DOGM.

2. Signs and Markers

The identification signs were inspected. They contain the necessary information to meet the R645 Coal Rules.

3. Topsoil

The topsoil piles were inspected with no signs of wind or water erosion. There is not abundance of vegetation growing on the piles. There was some thistle nearby and the permittee will have them removed.

4.a Hydrologic Balance: Diversions

The diversions and culverts were open and would function during a storm event. No water was flowing within the diversions during the inspection.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The sediment ponds were dry and not likely to discharge in the near future. The embankments were stable. Many of the sediment ponds are incised. The inlets and outlets were stable with no signs of erosion.

7. Coal Mine Waste, Refuse Piles, Impoundments

I inspected the refuse pile and did not see any hazardous conditions. The out slopes were stable. The refuse pile has not been used for some time. The material was hand pick and therefore high in rock content.

8. Noncoal Waste

The site has been inactive and therefore the site is free of non-coal waste material.

15. Cessation of Operations

This site is considered active and could begin loading trains and storing coal at anytime.

16.a Roads: Construction, Maintenance, Surfacing

Roads have been maintained and the diversions and culverts are open and would function during a storm event.
